- 3. Arbitration Chair for InterOp / Parks Fields
 - o Parks Fields has agreed to be arbitration chair
 - InterOp starts May 1
- 4. OFED 4.8 approval / Dual License / roll call for level of concern at BoD meeting ?
 - Email vote for 4.8 approval has been rejected
 - The vote for approval for release of OFED
 - \circ The board needs to communicate their acceptance that this issue is solved
 - Jason Gunthorpe asserts that much of OFED user space code is not dual license
 - The licensing of many components is not clear, and this violates bylaws
 - The issue of how to deal with this needs to be resolved
 - The list of tainted files should be included with distribution, if possible
 - The near term and far term solutions are different

- The solution may require the definition of Open Fabrics software
- The bylaws revision depends on this issue being resolved or not being an issue anymore
- If OFED is not OFS, then there is no dual-license issue
- The board can possibly vote to change the relationship of OFED to OFS, more easily than continually voting to violate the bylaws
- o Board members are encouraged to read the relevant sections of the bylaws
- The bylaws can be amended to omit licensing requirements; however, the bylaws will be renewed wholesale
- There may be a motion to resolve this by the next board meeting
- 5. InterOp discuss/agree on test framework(s) we want UNH-IOL to adopt
 - Bringing in Linux distros
 - Suse and Red Hat use different IDE, continuous integration, and testing environments
 - OFA will fund UNH-IOL to integrate and learn frameworks
 - UNH-IOL is working to provide results in a timely manner
 - UNH-IOL prefers to use a distribution agnostic and python-based customized software stack for testing and reporting
 - Discussion will be tabled until UNH-IOL is ready for interdistribution testing
 - What do the distributions gain? Alpha and Beta testing of their distros with hardware
 - Doug Ledford hopes to get functional testing out of the process
 - Detailed conversation continues at IWG meeting
 - OFA is considering financial support of effort
